## Passenger Estimates for the 2026 Summer Peak Period

Narita International Airport Corporation has compiled estimates for the number of passengers expected to use Narita Airport during the Summer Peak period. Please note that congestion is expected at the airport during this period, therefore we recommend using public transportation and arriving well in advance.

### 1. Congestion Period

August 7, 2026 (Friday) – August 16, 2026 (Sunday), 10 days

# Important Information for Passengers

Congestion is expected at the airport during the Summer Peak period. To ensure a comfortable experience, especially for departing passengers, please review the following information.

## ■ Guidance on Arrival Time

Due to airport congestion, check-in procedures, baggage drop-off, and security checks may take longer than usual. Considering possible road traffic, crowded airport parking lots, and potential delays in public transportation, please check your flight's departure time and allow extra time when traveling to the airport.

## ■ Guidance on Security Screening

For smooth security screening, please review the rules for carry-on and checked baggage in advance. For more details, please refer to the following:

During the following time periods, it may take longer to pass through the security checkpoints. Therefore, we recommend proceeding through security early. The expected peak congestion times at the security checkpoints are as follows:

### 【International Flights】

Terminal 1 North Wing: 07:00–08:00, 15:00–16:00

Terminal 1 South Wing: 07:00–08:00, 15:00–16:00

Terminal 2: 07:00–08:00, 11:00–13:00, 15:00–18:00

Terminal 3: 17:00–18:30

### 【Domestic Flights】

Terminal 1 (ANA, Peach Aviation): 06:30–8:00, 15:00–16:00

Terminal 3 (Jetstar Japan, Spring Japan): 06:00–08:00

Terminal 2 (JAL) does not have specific peak congestion times, but please proceed through security early, especially just before your flight's departure time.

Please note that congestion times may vary depending on the day of the week and flight schedules.
