Narita International Airport Concludes Sister Airport MOU with Taiwan Taoyuan International Airport

- Concluded along with the Sister City Agreement between the cities of Narita and Taoyuan to Strengthen Cooperative Ties in Private and Public Sectors -

Tokyo, 16 September 2016: Narita International Airport Corporation (NAA) is delighted to announce that NAA and Taoyuan International Airport Corporation (TIAC) signed a memorandum of understanding today on a sister airport relationship with the objective of strengthening cooperative ties between two large hub airports in Asia, expanding their respective air service networks and providing high quality services to the customers of the two airports.



The flight frequency of Narita-Taipei (Taoyuan) route is presently the highest on Narita's network with more than 140 flights a week. It is anticipated the signing of this memorandum will increase the number of passengers on the route by further stimulating tourism. We believe that this will bolster the Narita's network in its role as the gateway between Asia and North America, and lead to added convenience for the customers of the two airports.

Furthermore, the Cities of Narita and Taoyuan also concluded their sister city agreement on the same day as a symbol of the intent of the relevant government agencies and airports to work concertedly in promoting people and cultural exchanges between the two cities and expanding the aviation demand between Japan and Taiwan. In signing this memorandum, NAA and TIAC commit to taking to a new level the sharing of the expertise and technology they have accumulated as a result of their experience in airport management through regular exchanges of views and sharing of information on airport operation and management methodologies. Discussions will also be held on the implementation of joint projects aimed at expanding the air transport demand between the two airports.
